**Program Area Review Impacting Woodbine MS, Crestview PS,
Bavview MS, Avondale PS**

A process has begun to review school boundaries and programming locations to address changes required at four schools (three in Ward 13) due to growing density within the North York Community. To complete this process, a Program Area Review Team (PART) including TDSB Staff, parents/guardians/caregivers, and Trustees will be formed to provide feedback on the proposed options and discuss alternatives.

Issues Under Review

Issue 1: Reduce enrollment pressures at Avondale PS due to growth in local student population.

Issue 2: Reduce travel distance for middle school students residing in residential buildings along Sheppard Ave E between Bayview Ave and Leslie St. Students are currently redirected to Woodbine MS with a travel distance of up to 4.5KM.

Proposed Solutions

Issue 1 Solution: Permanently relocate Avondale Alternative School (JK - 8) to Bayview Middle school.

Issue 2 Solution: End all redirections to Woodbine MS for grade 6 - 8 students residing in the review area. Students will be able to attend Bayview Middle School, which is within walking distance to much of the community. Option to attend Woodbine MS will continue to be available through the Out of Area Admissions process until Woodbine MS becomes full.

Out of Area Admissions

TDSB students have the opportunity to access schools outside of the school that is designated to serve their home address by applying for Out-of-Area Admissions. Acceptance at these schools is subject to space availability and program suitability.

Each year in November, schools are classified Out-of-Area Admissions based on the space they have available for the upcoming school year.

Elementary Out of Area Admissions – Key Dates:

Application: January 9, 2023 - February 10, 2023 at 4:00 p.m.

Round 1: Families to be informed of the status of the application Wednesday, March 8, 2023; Families must confirm acceptance of the offer by Tuesday, March 21 at 4:00 p.m.

Round 2: Families to be informed of the status of the application Wednesday March 22, 2023; Families must confirm acceptance of the offer by Tuesday, March 28 at 4:00 p.m.

Secondary Out of Area Admissions – Key Dates:

Application: January 9, 2023 - January 27, 2023 at 4:00 p.m.

Round 1: Families to be informed of the status of the application Wednesday, February 8, 2023; Families must confirm acceptance of the offer by Tuesday, February 14 at 4:00 p.m.

Round 2: Families to be informed of the status of the application Wednesday February 15, 2023 Families must confirm acceptance of the offer by Tuesday, February 21 at 4:00 p.m.

Final Round: Families to be informed of the final status of the application request Wednesday February 22, 2023; Families must confirm acceptance of the offer by Friday, February 24 at 4:00 p.m.

TDSB Students must finalize their acceptance by completing and submitting the corresponding course selection for the accepted school in myBlueprint no later than Monday, February 27, 2023.

Middle French Immersion Application Process

The entry point to the Middle French Immersion program for September 2023 is Grade 4. The online application process for Middle French Immersion will take place between January 9 and February 3, 2023. An offer of placement in the program (not a specific school) is guaranteed to all on-time applicants. Families with an older sibling currently enrolled in a French program and who will be in attendance next year are still required to complete an online application for the new student. The Board is taking a number of different steps to improve school safety across the Board including the hiring of additional staff to better support students, staff and school communities, creating a Safe Schools Audit Team to work with schools on safety issues, and forming an Expert Table Reference Group related to school and community safety with representation from recognized service providers across the City (e.g. The Centre for Mental Health and Addiction, Toronto Public Health, City of Toronto) and include students, parents, Trustees, staff, and faith-based groups.
